Rebecca Ross reports having attended the wrap-up of the Aloha-Reedville Study and the consensus was from CPO6 Members that were there that Constance the new head of CPO6 is not interested in leading on this issue; so Washington County is looking to the Aloha Business Association to be the driving force behind implementation of the 'Study' results.
